# **Demosphere**

- Approx. 80% of clubs have signed contracts (estimated 18,000 members)

- Hiring new manager to replace Bob Tobin one salary
- Building staff decreased from 256 hours to approx. 160 hours per week
- Need to address the Newbridge contract
- Looking at a decrease of turf rental fees for April 1 through October 31 to compete with outdoors;
   November 1 through March 31 fees will remain the same
